About University of Cincinnati

The University of Cincinnati traces its origins to 1819, the year of the founding of the Cincinnati College and the Medical College of Ohio. In 1870, the City of Cincinnati established the University of Cincinnati, which later absorbed the earlier institutions. In 1906, UC created the first cooperative education program in the United States through its College of Engineering. For many years UC was the secondoldest and second-largest "municipally-sponsored, state-affiliated" institution, entering a transitional period culminating on July 1, 1977, when the university became one of Ohio's state universities.

The University of Cincinnati is located in southwest Ohio. UC includes a main academic campus often called "West Campus," a medical campus known as "East Campus," a branch campus in suburban Blue Ash, and a rural branch campus in Clermont County just east of Cincinnati. Total enrollment (1999-2000): 33,342.

The University of Cincinnati is ranked 112th in the National Science Foundation Award Summary of Top 200 Institutions in FY2000. (OSURF is 38, CWRU is 106, KSU is 131, OSU is 157, OU is 159, UofA is 161 and UT is 197.)

UC is ranked as a Doctoral/Research University-Extensive in the 2000 edition of the Carnegie Classification of Institutions of Higher Education. This places it in a select group of 101 public and 48 private institutions. The other Ohio institutions with the ranking are CWRU, KSU, OSU, OU and UT.

Workshop A (Additional cost =\$30)

Fundamentals of Research Administration This workshop is designed to share a perspective on the fundamentals of research administration including understanding the role of the sponsored program office, defining functions and responsibilities of those engaged in the research enterprise, identifying funding opportunities (learning to fish), mastering the terminology of pre- and post-award activities, proposal development and preparation, institutional review, and where to go when you need help. The workshop is designed for those with three or fewer years of experience. **Presenters:** Dr. Cynthia Price is the Director of the BGSU research office. She has been a research administrator for the last eighteen years involved primarily with pre-award activities and staff training. Her area of expertise lies in Higher Education Administration and building university research infrastructure. Robin Euler, a member of the SPAR Office at BGSU for eight-years, and Sherri Fischer, ten-year veteran of the Research Office at UT, are in charge of proposal development, budgeting and every aspect of pre-award activities. Tom Kornacki has taught the faculty and graduate students "to fish" and he leads the BGSU effort to establish its ERA infrastructure.

Workshop B (no charge)

University of Cincinnati Tour Not your traditional "workshop," this session will be a casual tour of the University of Cincinnati starting with a brief videotape overview of the city of Cincinnati and the University. Then a walking/driving tour of the West Campus and the Medical Center (East Campus). Time and weather, permitting, we will tour the Children's Hospital Medical Center of Cincinnati, located near the UC Medical Center. UC has received architectural and design attention for its "Master Plan" involving world-class architects and buildings set in an urban university environment. Compliance Topics and Issues - What's New (and Old) in 2001 This workshop will review and address such critical research administration compliance topics and issues as: Human Subjects (IRBs), Animal Care (IUCAC), Biohazards and Safety, and Intellectual Property. Special emphasis will be placed on current regulations and emerging trends in these areas, with guidance for those of us who work in research administration and management of faculty research. **Presenters:** Linda M. Harpster, JD, Associate General Counsel, University of Cincinnati; Richard J. Kordal, JD, Director, Intellectual Property Office, University of Cincinnati.

Workshop D (Additional cost =\$30)

Casting a Wide Net: ERA Lessors Learned and Works in Progress from BGSU's Office of Sponsored Programs and Research This interactive session will explore the challenges experienced by a mid-sized institution as it prepares for full ERA implementation. Small sponsored research offices face the dual challenges of tight time lines and low resources. Join this session to learn how one short-staffed office began creating its virtual office on the web in order to allow the staff to devote more time to proposal development, support of institutional research centers, and facilitation of intra- and inter-institutional collaboratives. Presenter: Tom Kornacki began a career in grants management in 1993, and was in charge of grants and communications for the second largest network of non-profit community health centers in Ohio. He came to BGSU in 1998 to assist the implementation of electronic research administration.

Challenges and Opportunities in the Ohio Higher Education Research Enterprise (tentative working title) by: Dr. Howard Jackson, Ph.D., Vice President for Research and University Dean of Advanced Studies, University of Cincinnati.

Consideration of the Stakeholders in Research Grant and Contract Administration Research grant and contract administrators have a great number of causes, individuals, and constituencies, and institutions to whom they owe allegiance and accountability. This session will discuss strategies to help strike the balance which is most likely to satisfy these obligations, recognizing that stakeholder interests may be in conflicting. Presenter: Dr. Charmaine C. Streharsky is Director-Emeritus of Research Services and Sponsored Programs at the University of Akron and presently a Visiting Assistant Professor in Public Administration and Urban Studies. Her teaching areas include grant (proposal) writing, leadership and decision making, and ethics in public service. She has been in research grant and contract administration and public administration for more than 20 years and has served in various capacities at national SRA and NCURA meetings. She has authored publications in the SRA Journal and NCURA's Research Management Review.

Post Award Issues in Sponsored Programs Administration This session will focus on a variety of post-award issues including award processing, expenditure review, Federal Regulations, cost share documentation, subcontracts and billing. It will also address issues on letters of credit, prior approvals, financial reporting and closeout procedures. **Presenter:** Glen Jones, MBA, Associate Director, Office of Research and Sponsored Programs, Wright State University. He has over twelve years of experience in research administration at both Central State University and Wright State University. Currently, he oversees the post-award area of the office including award processing, account setup, expenditure review, cost share, subcontracts, billing, letter of credit, financial reporting and closeout of all grant/contract accounts for the university.
