RAD was created in partnership with the [Cohort for Efficiencies in Research Administration \(CERA\)](#). The 2025-2026 NYU NYC RAD series consists of the following sessions:

Session One

- Topic: “The APLU Decadal Survey of Senior Research Officers and their Responsibilities”
- Presenter(s): *Dr. Kevin Cooke*, Director of Research Policy - Association of Public and Land-grant Universities (APLU)
- Description: This session will showcase an analysis of a national survey (n=107) of senior research officers (SROs, e.g. Vice Presidents of Research) at member institutions of the Association of Public and Land-grant Universities. This data is compared to the prior decade's state of the profession as measured by Droegemeier et al. (2017) and includes measurements of how often specific responsibilities are included in SRO portfolios and what professional backgrounds these leaders are selected from. By identifying SRO concerns and career paths as of December 2024, attendees can have a discussion on how they collaborate with their SRO to address challenges to research universities, and plan their next steps to greater research leadership.

Session Two

- Topic: “The Future of Space—how F&A space survey concepts may shape tomorrow’s future cost allocations”
- Presenter(s): *Martin Smith*, Director, Education & Research - Huron Consulting Group; *Andres Chan*, Director of Financial Analysis - University of Southern California
- Description: This session examines how functional space surveys have historically shaped indirect cost allocation and how they are poised to evolve. We'll explore current applications—such as allocating Facilities & Administrative (F&A) costs, responding to surveys like the NSF Science and Engineering Research Facilities (SERF) survey, and aligning research space with financial performance metrics (e.g., indirect cost recoveries, faculty start-ups and return on investment, and service/recharge center activity). Finally, we will look ahead to emerging approaches, including how proposed FAIR models could transform space-based cost allocation and strategic planning for research institutions.

- Description: This interactive session will provide participants with a brief overview of the NSF SECURE Center. Most of the session time will speak to the resources available through the center, plans for growing the research security resources available to SECURE and how stakeholders from research security and compliance professionals, to faculty and department administrator and central staff may benefit from SECURE’s work. The presenters will provide expanding research security resources. Participants will learn how faculty, administrators, compliance professionals, and central staff can benefit from SECURE’s tools and initiatives. The session also highlights engagement opportunities, including working groups, feedback forums, training events, and online communities—inviting stakeholders to help shape the future of research security.

- Description: This session will provide an overview of: (1) various research ethics training requirements by federal agencies and (2) PHS requirements for addressing research misconduct allegations effective on January 1. Participants will receive a framework for an effective compliance program to support research integrity.

- Description: Budgets are the driving force in sponsored projects. It is the part the investigators know the least about, the part institutions and auditors focus on the most, and the area in which the research administrator can have the biggest impact. This session will discuss how RAs interact with budgets both at the pre-award stage where budgets are developed and established, and at the post-award where budgets are maintained and adjusted. General principles and possible best practices will be reviewed.

Our panel will also demystify HB1 visa fines and fees, sharing tips for standardizing processes and avoiding common pitfalls. To tie it all together, we'll explore real-world strategies for enforcing compliance and managing risk, giving participants practical tools to support their teams and safeguard project integrity.

- Description: Sometimes in order for sponsored projects to be managed properly, additional unfunded agreements may be needed. This session will discuss the nature and function of mechanisms such as Non-Disclosure, Data Use, Material Transfer, and other contracting tools. Common issues and possible best practices concerning the necessity and negotiation of supporting unfunded documents will be reviewed in detail.
